

VILLAGE OF PORT CLEMENTS

BY-LAW NO. 241, 1993

A By-Law to establish, maintain and operate grounds for the disposal of garbage.

WHEREAS the Village of Port Clements desires to establish, maintain and operate grounds for the disposal of garbage of all kinds of noxious, offensive, or unwholesome substances, which grounds are located outside the boundaries of the said Village;

AND WHEREAS the approval of the Minister of Municipal Affairs, Recreation and Housing has been obtained;

NOW THEREFORE, the Council of the Village of Port Clements enacts as follows:

1. In this By-Law, unless the context otherwise requires;
 - a) the words "Village" shall mean the Village of Port Clements;
 - b) the words "the Council" shall mean the Council of the Village of Port Clements.
2. It shall be lawful for the Council to establish, and the same is hereby established, grounds for the disposal of garbage of all kinds and noxious, offensive or unwholesome substances located outside the boundaries of the Village of the following described land:
 - North 1/2 of South West 1/4 Section of District Lot 401, Queen Charlotte Land District; Lease # 632158.
3. It shall be lawful for the Council to maintain and operate such grounds and for greater particularity the Council shall be empowered as follows:
 - a) to acquire works, machinery, tools, material, apparatus and equipment necessary and proper for the purposes aforesaid;
 - b) to employ such officers and employees necessary and proper for the purposes aforesaid at such remuneration or payment as the Council may from time to time determine;
 - c) to carry out any work incidental to the purposes aforesaid.

d) to levy user fees for garbage of all kinds and noxious, offensive or unwholesome substances as per Schedule A attached to and forming part of this By-Law.


4. This By-Law shall be cited as the "Garbage Dump Establishment By-Law No. 241, 1993".



SCHEDULE A


GARBAGE DUMP ESTABLISHMENT BY-LAW NO. 241, 1993.

1. For residents and property owners in the Village of Port Clements, user fees will be levied as follows:
 - a) Dump Truck/Garbage Truck Loads: \$20.00

2. For those not residents/property owners in the Village of Port Clements, user fees will be levied as follows:
 - a) Garbage Bags: \$ 1.00
 - b) Pickup Loads: \$10.00
 - c) Dump Truck/Garbage Truck Loads: \$20.00
 - d) Derelict Vehicles: \$25.00
 - e) White Wears (fridges, stoves, washers, dryers, etc.): \$ 5.00


