

VILLAGE OF PORT CLEMENTS

BY-LAW #254

A By-Law To Amend the "Village of Port Clements 5 Year Capital Expenditure Program For The Years 1993-1997, By-Law #248, 1993".

WHEREAS \$50,000 in Sewer Utility Revenues was reallocated by Annual Budget Amendment By-Law #253, 1993:
