BYLAW NO. 274, 1996

A Bylaw to close and stop up that portion of undeveloped right of way, Plan 1079, adjacent to Lot 18, Block 30, Plan 1079 and Block 35, Plan 1079.

WHEREAS the Municipal Council may, by bylaw, stop-up and close to traffic any highway, or portion thereof, pursuant to the Municipal Act;

AND WHEREAS the road dedicated by Plan 1079, District Lot 746, could is not required for road, public laneway or municipal purposes;

AND WHEREAS it is considered that this portion of road closure is in the best interest of the Municipality;

NOW THEREFORE, the Council of the Village of Port Clements in open meeting assembled, HEREBY ENACTS AS FOLLOWS:


- 1.0 That part of land, named "closed road" as show in heavy outline on the Explanatory Plan prepared by, David J. Hardwicke, B.C.L.S, certified correct the 7th day February, 1996, and annexed hereto as Schedule "A" to this Bylaw, is hereby stopped up and closed to traffic.
- 2.0 The Municipal Clerk is hereby authorized to petition the Minister of Municipal Affairs to abandon the said road, more particularly described in Section 1.0 herein, and vest title thereto in the name of the Village of Port Clements.
- 3.0 This Bylaw may be cited as the "Village of Port Clements Road Stopping Up and Closing Bylaw No. 274, 1996".


