A true copy of By-Law No. 117 registered in the office of the Inspector of Municipalities this 14th day of June 1982

A By-Law to authorize the expenditure of monies in the Capital Works, Machinery and Equipment Reserve Fund.

WHEREAS there is an unappropriated balance in the Capital Works, Machinery and Equipment Reserve Fund established pursuant to By-Law No. 30 of Sixty Three Thousand Four Hundred and Seven Dollars as at January 14, 1982 which amount as been calculated as follows:

Balance in Reserve Fund at December 31, 1980 49,743.00

Add: Additions to fund including interest earnings for current year to date. 16,664.00

Deduct: Total of expenditures By-Laws for current year to date. 3,000.00

Balance in reserve fund at January 14, 1982 63,407.00

AND WHEREAS it is deemed desirable to expend a portion of the monies set aside under said By-Law No. 30 for the purpose of purchasing a three quarter ton Pick-up truck.

AND WHEREAS the approval of the Minister of Municipal Affairs has been obtained:

THEREFORE the Council of the Village of Port Clements, in open meeting assembled, enacts as follows:

1. This By-Law may be cited as the "Capital Works, Machinery and Equipment Reserve Fund Expenditures By-Law No. 117, 1982".

2. The sum of Two Thousand Six Hundred, (2,600) is hereby appropriated from the Capital Works, Machinery and Equipment Reserve Fund to be expended for Pick-up truck - Three quarter ton.

3. The Expenditure to be carried out by monies hereby appropriated shall be more particularly specified and authorized by resolution of Council.

4. Should any of the above amount remain unexpended after the expenditures hereby authorized have been made, any unexpended balance shall be returned to the credit of the said Reserve Fund.
