

WHEREAS it is deemed desirable to amend the "Village of Port Clements Zoning By-law No. 41, 1977" to zone this property;

NOW THEREFORE, the Council of the Village of Port Clements in open meeting assembled enacts as follows:

1. That the Village of Port Clements Zoning By-law No. 41, 1977 is hereby amended by:

(a) Schedule "A" of the Village of Port Clements Zoning By-law No. 41 1977 is hereby amended by rezoning Lots 1-4, Block 21, Plan 1079 from Industrial to Commercial Zone as shown on the attached map marked "Schedule A" to By-law No. 85, 1980 and outlined in red.

(b) Schedule "A" of the Village of Port Clements Zoning By-law No. 41, 1977 is hereby amended by rezoning Lots 1-8, Block 40, Plan 1079 from Multiple Dwelling to Residential Zone.

Lots 1-24, Block 39, Plan 1079 from Multiple Dwelling to Residential Zone.

That part of Section 28 currently zoned as Multiple Dwelling from Multiple Dwelling to Residential Zone, as shown on the attached map marked Schedule "B" to By-law No. 84, 1980 and outlined in red.

2. This By-law may be cited as the Village of Port Clements Zoning By-law No. 41, 1977 amendment By-law No. 85, 1980.

READ A THIRD TIME THIS 28th day of April , 1980.

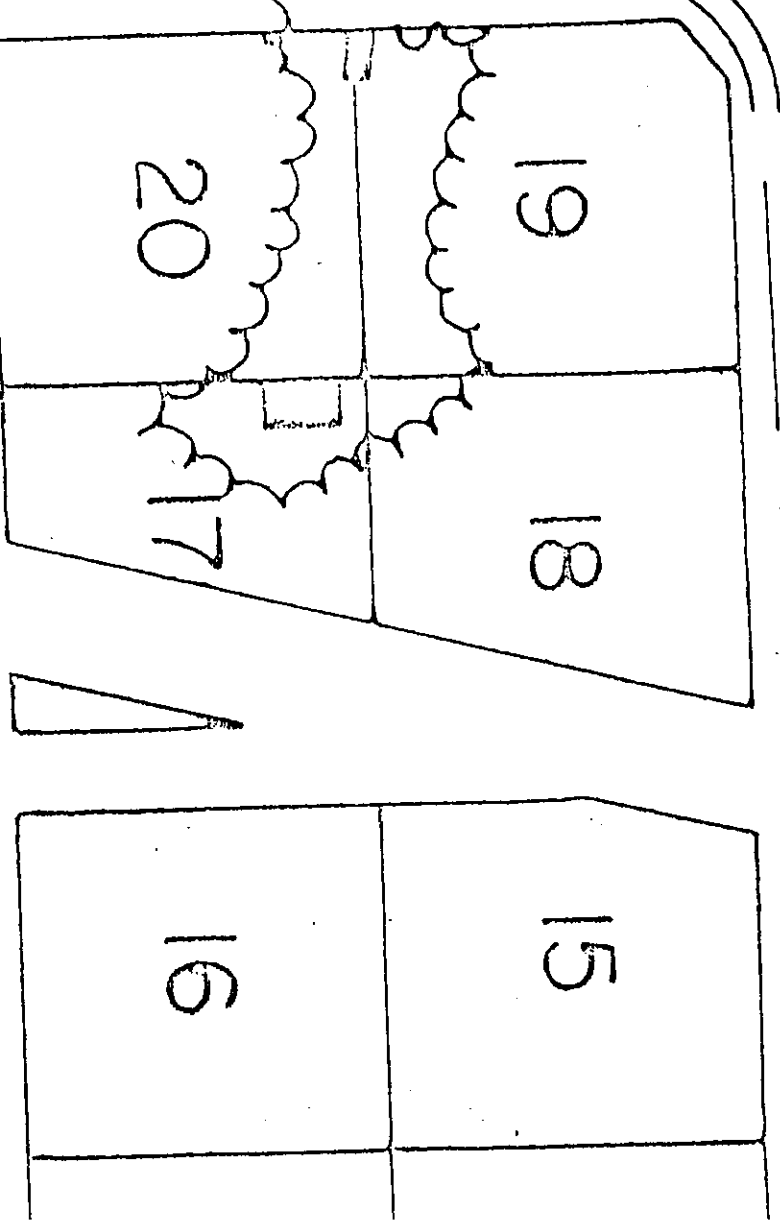
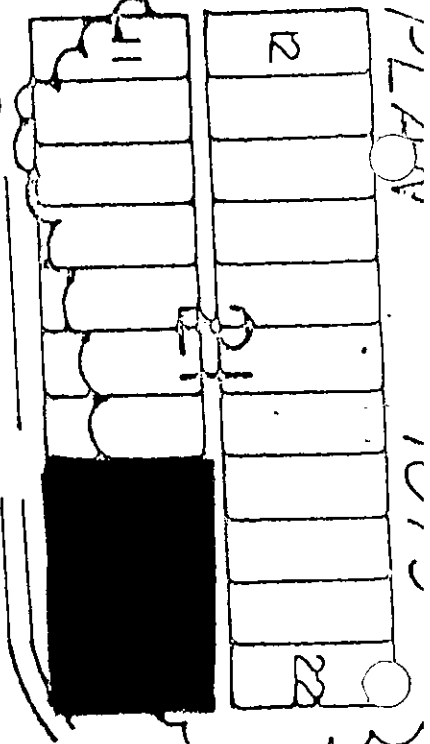

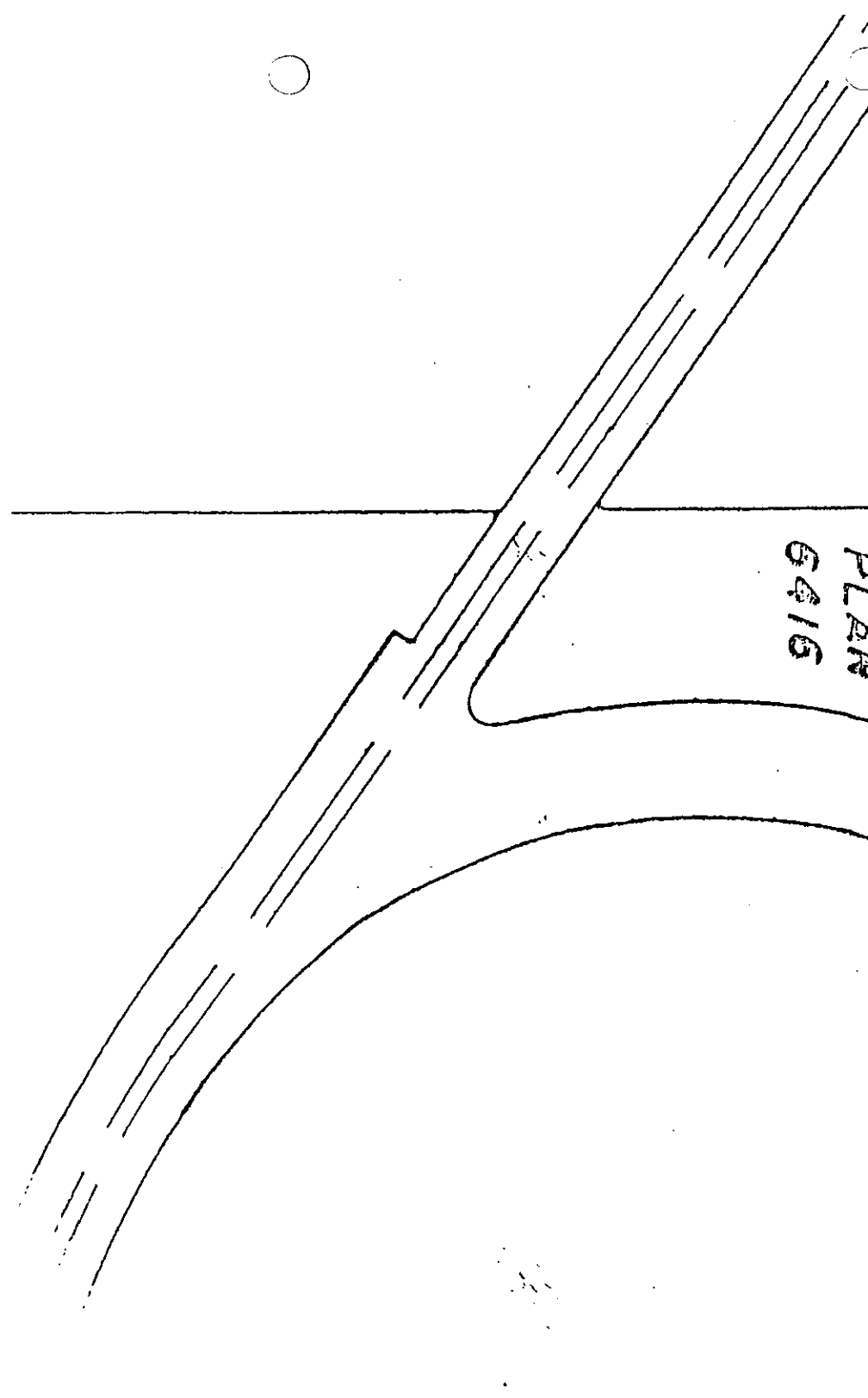
